ampore district is famous for its saffron followed by other districts of Kashmir when the spice saffron comes to our mind, with limited cultivation in the Kishtwar district of Jammu provision. But when the Rajouri administration came up with the idea to cultivate Saffron on an experimental basis in the Darhal Subdivision as the climatic conditions are like the saffron growing area of Kishtwar, the results turned out to be successful.

The farmer on whose field the trial basis was carried on 15 marlas of the area from a total land area of 15 Kanal, sees this as an opportunity to increase income. The agriculture department of Rajouri is working to enhance the socioeconomic status of the farmers by encouraging them to switch to commercial farming from subsistence farming, and real action is being made in this direction. Saffron Cultivation Trial is one more step forward in this direction to achieve this goal and a lot of opportunities lie in the coming future.

## **Role of Investment Companies**

An investment company is one whose principal business is the acquisition of shares stocks, debentures, and other securities. In the building up and control of corporate enterprises, investment companies play a vital role. Almost all the big groups have a cluster of investment companies-both as a tool to exercise control over their immediate flagship companies and later to extend their holdings in other companies.



As the diagram indicates, it is the investment company through which the funds of the promoters are channelized into their companies. Investment companies by their very nature have a certain special advantage, both under the Companies Act and under tax laws. The concept of investment company occurs in two places in the Companies Act, namely, under section 372 and Note L of the general instructions for the preparation of Schedule 4 to the Companies Act.

However, with the abolition of wealth tax on financial investments, the creation of multi-layer investment companies has lost its relevance. It may also be noted that under the present law, dividend income is exempt from income tax. Under the Gift Tax Act, the valuation rules of investment companies are relevant when gifts of an unquoted investment company's shares are made.
